Provincial Police Headquarters in Gdańsk (KWPG) takes part in a project within the Interreg Baltic Sea Region Programme for the first time. As KWPG is currently looking for project partners and establishing partnerships, it cannot be defined at this stage whether future project partners have taken part in the Interreg Baltic Sea Region Programme previously.

# 5.1 Specific challenge to be adressed

Polish Police (and respectively Pomeranian Police ona regional level) as a uniformed and armed formation responsible for maintaining public safety and order, initiate and organise preventive measures to reduce crime and offences, as well as all criminal behaviour, cooperating with state and local government authorities, as well as non-governmental organizations. A group of police officers closest to the citizens are community officers. They maintain direct contact with local communities in their areas, identifying their needs and expectations in terms of broadly understood security, both individual and public. Community police officers cooperate with citizens to diagnose local problems, determine their causes and help to find effective ways to solve them. Community officers are on the frontline to prevent and fight domestic violence, being the most common and harmful at the same time.

The main objective of the project is to provide comprehensive support to victims of crime by enhacing the skills of community officers and providing them with tools to remain closer to the citizens.

The target groups off the project will be: - children and young people in primary and secondary schools in the Pomeranian Province (Poland),





Lithuania and Sweden

- parents of children and young people in primary and secondary schools in the Pomeranian Province, Lithuania and Sweden

- victims of crime, with particular emphasis on people experiencing domestic violence – children and adults,

- community officers and their supervisors in the Pomeranian province, heads of Prevention Departments of the Provincial Police Headquarters/Municipal Police Headquarters/County Police Headquarters in the Pomeranian Province, Lithuania and Sweden.

# 5.2 Focus of the call

As the focus of the call is put on small places and rural areas, the participants and beneficiaries of the project will be community officers from 15 county Police Stations in the Pomeranian Region, situated in: Pruszcz Gdański, Tczew, Malbork, Sztum, Kwidzyn, Wejherowo, Puck, Lębork, Starogard Gdański, Nowy Dwór Gdański, Bytów, Kościerzyna, Kartuzy, Chojnice and Człuchów. All of them have subordinate units, located in rural areas. Therefore the citizens have limited access to police, different offices and NGOs. Especially victims of domestic violence are often left on their own, receiving scarce or no aid at all. The project aims at fulfilling this gap, providing support both to the town/village dwellers and the police officers working in these areas. Similarly, project partners will be asked to also select less urbanised areas (small towns and villages) to benefit from the project.

#### 6. Transnational relevance

The most important reason for cooperate transnationally in implementing the project is the fact that Police in other countries than Poland have great experience in building good relationship with citizens. Thus, police officers can learn from their colleagues from abroad. Also, they can create professional networks which will support them after the project is finished. Project partners will participate in trainings and staff exchanges. Moreover, they will all prepare a manual for community officers and launch an anti-violence campaign.

# 7. Specific aims to be adressed

Building trust that could lead to further cooperation initiatives

Building mutual trust between Police units and between Police units and citizens is a core aim of the project. This will be conducted by common activities, which will enable all parties to get to know each other and develop long-lasting cooperation.

Initiating and keeping networks that are important for the BSR
