Russia's military invasion of Ukraine has not only caused one of the world's most tragic humanitarian crises but resulted in economic devastation that will influence territories far beyond Ukraine's borders. Main project activity is to create a friendly economic environment for woman entrepreneurs and innovators from Ukraine but also from others countries in a similar situation. It includes establishing financial instrument: micro-capital seed fund. Project is territorially oriented at all BS regions. The different economic environment in partnership gives possibility to choose preferred country for each start-up referred to regional specializations. We plan to settle single eco-system for viable or innovative start-up's from Ukraine. BS regions will benefit from boosting entrepreneurship and competitive (knowledge-based) transnational economic relations. All EU members and their economies will benefit from professional activation of vulnerable groups of refugees but what is the most relevant, war immigrants will be supported with professional, long term business oriented help. It will prevent a number of social issues and immigration- related problems. It is worth to mentioned that one of the aspects of recovering from a war or catastrophic trauma in its last phase is taking up professional activity. Rebuilding life anew, is greatly helped by any professional and economic activity. It influences not only economy but also mental wellbeing of populations.

1.8. Summary of the partnership

3. Relevance

3.1 Context and challenge

Currently all Europe- including BSR countries -is strongly involved in helping Ukraine heavily impacted by Russian military invasion. An ongoing refugee crisis began in Europe in late February 2022. Almost 5.2 million refugees have left Ukraine and 90% of them are women and children. The invasion caused one of the largest refugee crisis after the II World War with the highest refugee flight rate globally. The current situation is a huge challenge for EU countries especially in providing this vulnerable group with the possibility of receiving appropriate qualification trainings and employment, which will not only enable them to meet their basic needs but allow them to develop professionally. Very soon other EU countries and regions, including Baltic Sea regions will face similar scale of challenges as Eastern and Central Europe due to upcoming wave of refugees from Ukraine as we are observing an ongoing relocation process from Eastern countries to all others in EU. Taking this into account, in addition to the social assistance offered, it is important to create a special support mechanism for the development of refugee entrepreneurship, beneficial for this target group, but also for the economy of supporting countries. In many countries of the Baltic Sea region there is a problem with the possibility of employment for women. There is a great demand for manual laborers, mainly male-oriented but not so much job offers for women, and now we need a lot of such. Women's professions in these regions are still at a deficit. With this project, we want to contribute to the development and improvement of the professional situation of women who are coming to our countries.

3.2 Transnational value of the project

The partnership in the project is well planned and structured. It consists of representatives of the countries most often targeted as refugee destinations. In order for all goals to be achieved and realized, cross-border cooperation is essential. Each of the Partners contributes the knowledge gained as a result of working with migrants in their regions. As we have not faced such a migration crisis in this century, it is not possible for any of the partners to tackle this challenge alone. An important element during the implementation of our project, the exchange of knowledge acquired in each region will be important, which will allow the creation of a uniform cooperation system for the regions covered by the project activities.

As mentioned earlier, the countries involved in the implementation of the project are the target countries for many refugees from the regions of Ukraine. The involved Science and Technology Parks will be a valuable support in developing a startup development strategy. It is the knowledge necessary to achieve the assumed goals of the project.

5.6.3 Description of the group of activities

Engagement of local societies and stakeholders is crucial for the solutions development. Developing the formula of participatory management activities (with active participation of community, enterprises, public administ., non-governmental organizations, research units) will help to create a solid workplan and report on needs and potential of each partner regions (in accordance with smart specializations).

Working groups of regional stakeholders will be organized and will integrate: enterprises, public administration, non-governmental organizations, research units, refugee women groups (1 meeting/month for diagnostic purposes in the first months of the project and less frequently – 1 meeting/3 months to consult on the effects of the project implementation). The main task is the collection and processing of the best practices for start-ups creation and benchmarking of available incubation and acceleration programs for start-ups. This will aim at transfer of know-how cooperation in the field of support tools creation.

Country-specific mapping of best innovation methods, identification of cooperation opportunities and knowledge transfer will tailor the overall approach to creativity, innovation and adapt it to the needs, target group and stakeholders.

Another task is collecting info on the target group, in particular their creative potential, ecosystem, goals and motivations (a professional survey will examine the needs of refugees in terms of the necessary creative skills and tools for entrepreneurial activities, helping to identify barriers and their needs with risk-taking, innovative ideas and predispositions to start own business.

Diagnosis of local needs and potentials of individual partner regions, with the active participation of community members and refugee representatives, allow to identify the specialization of individual partner regions and concentration with the support of refugees in the indicated industries and specializations. The ecosystem will be created in order to constantly support refugees who have innovative business ideas, including projects / inventions that reduce the impact on the natural environment (to implement eco-friendly solutions). Ecosystem members will help disseminate info about the Project and promote the best business ideas.

The ecosystem will be successively expanded with new entities having a significant impact on supporting innovation. Clusters will provide expert support in the area of the industries they represent.
