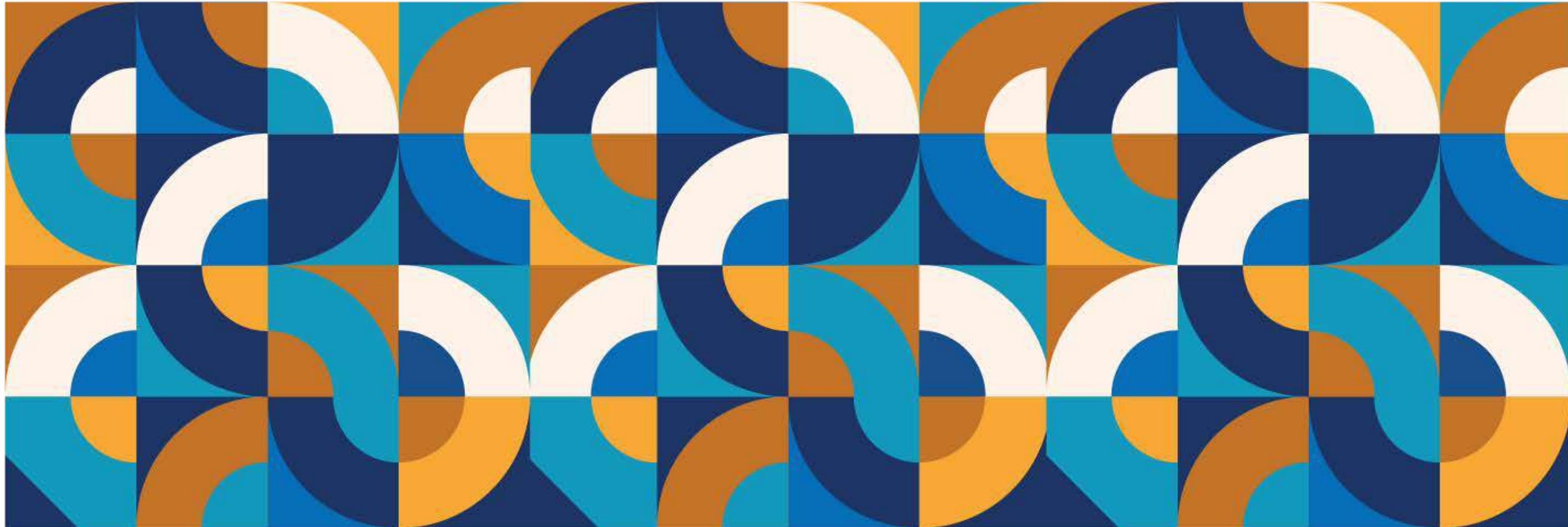

## Transnational cooperation programmes: a unique asset for the European Union

For over 25 years, Interreg transnational programmes have shown their ability to address complex socio-economic, environmental and societal issues at the European level. We firmly believe in the unique ability of transnational programmes to drive transformation and strengthen cohesion across Europe.

It also means supporting potential new member countries to comply with the *acquis communautaire* as they prepare for accession to the Union.

Through a wide range of project examples and stakeholder perspectives, this brochure illustrates this potential and the added-value of transnational

# Enhancing the Resilience of Alpine Space Snow Tourism Destinations and Communities to Climate Change

## Tourism - Resilience - Solidarity

Due to climate change, snow coverage in the Alps is very likely to continue decreasing in the future. In addition to the ecological impacts, small medium-altitude snow tourism destinations and their communities in particular must also consider the socio-economic consequences of the reduction of snow coverage.

The project BeyondSnow aims to increase the socio-ecological climate resilience of snow tourism destinations, to enable them to retain or even increase their attractiveness for residents and tourists. During the project, new sustainable development paths, transition processes and implementable solutions will be collectively devised.

Thanks to trainings and awareness-raising activities, citizens and decision-makers at different technical and political levels will be involved in this process.

# Atlantic InnoBlue Communities - ATLIC

Youth - Entrepreneurs - Community

The main goal is to create the Atlantic Innovation Blue Community network. Groups of youth, teachers, small businesses and public and private entities meet in innovation labs.

Together they select a top-of-priority blue economy challenge and work on a new business idea. Each group considers opportunities for creating jobs, avoiding migration from the area, creating tourist resources, and improving the maritime landscape and environment.

ATLIC is also setting up the Atlantic Area Open InnoBlue Academy, a key resource to ensure its transferability.

# YEP MED - Youth employment in ports of the Mediterranean

Youth - Skills - Job

Ports play a vital role in international trade and the Blue Economy, offering significant job opportunities, particularly through larger companies with higher job-absorption capacity.

To harness this potential, YEP MED enhances Technical and Vocational Education and Training (TVET) with targeted job placement schemes for NEETs in the Mediterranean, focusing on foreign trade, sustainability, digitization and port logistics.

Through innovative training for youth, women and NEETs, the project supported 4,650 individuals and secured over 850 internships and job placements in 514 companies, fostering inclusivity and social equity in the Mediterranean port ecosystem.

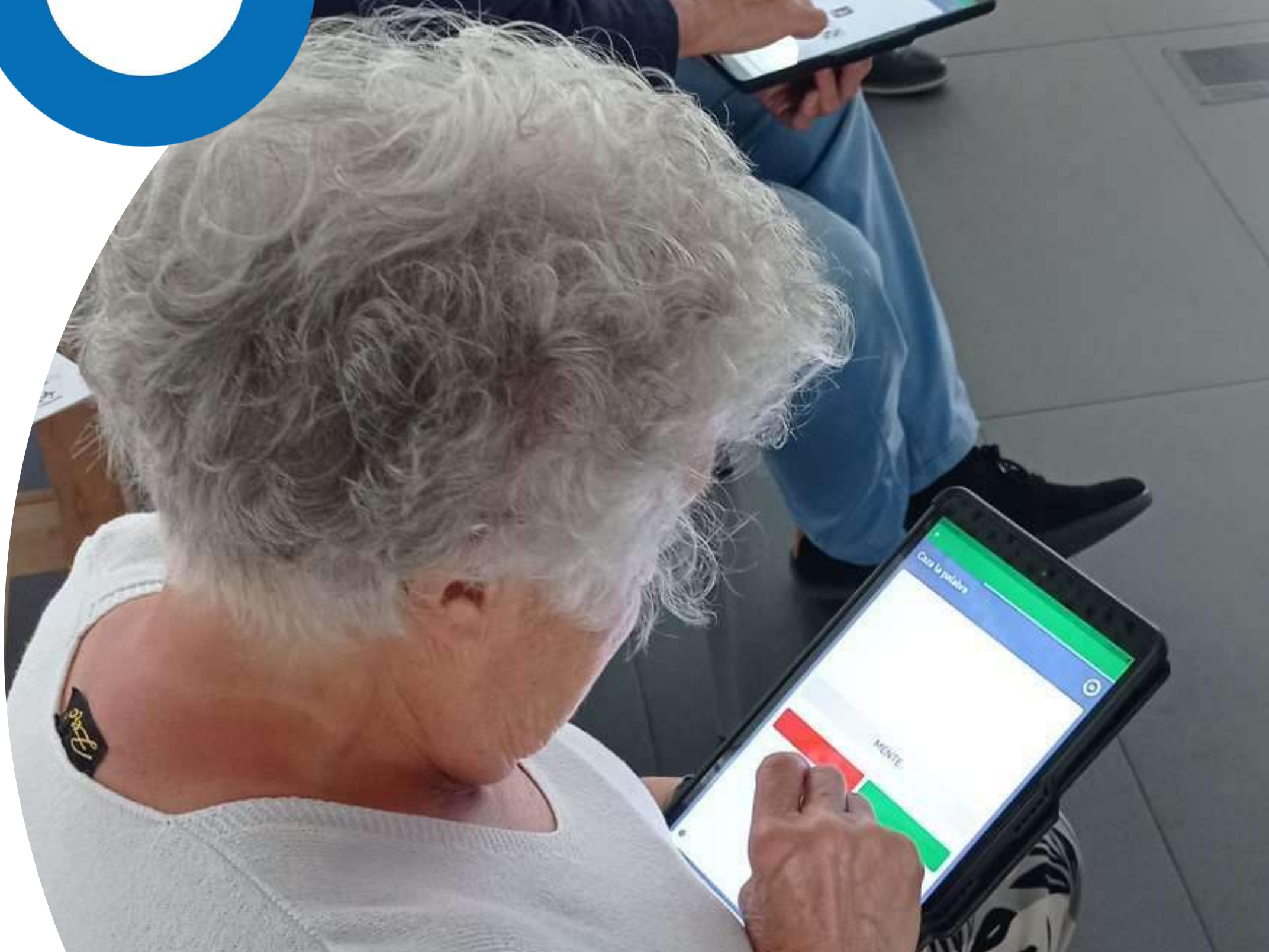
# Collective Intelligence and Social and Health Technology Labs to combat isolation and loneliness among the elderly

Senior citizens - Mental health - Empowerment

The reality of aging in the European Union presents a sobering statistic: 31.1% of older adults face their final years in solitude. This figure not only represents a significant humanitarian concern, but also highlights a growing social challenge as Europe's population continues to age.

MOAI LABS, a European R&D&I laboratory fighting unwanted loneliness and social isolation, has focused on the theoretical and empirical study of loneliness and the co-design, co-development and adaptation of technological solutions to the needs of the elderly that can somehow change their situation of unwanted loneliness and assess their impact on local and national policies.

## Participatory cross-border governance for transition management in central European cross-border regions

Border obstacles - Participatory governance - Resilience

The BorderLabs CE project transforms border regions into places of cooperation to address shared challenges together. It creates synergies and enhances resilience by integrating diverse cross-border initiatives into a cohesive transnational framework. By piloting innovative governance models across central Europe, it unites public authorities, researchers and citizens to develop long-term solutions that anticipate future risks. In the border area of Germany, Poland and Czechia, it creates a joint framework for transitioning regional economies to sustainable, low-carbon sectors. In the Italian-Slovenian border region, it fosters cross-border cooperation to promote sustainable tourism, while in the Hungarian-Slovak border area, it strengthens local supply chains through cooperative networks.

# Sustainable, Integrated Transnational Sediment Management in the Danube River Basin

Transnational river basin - Sediment management -  
Integrated territorial approach

Disrupted sediment transport and changes in the Danube River's hydromorphology are creating significant challenges. These include increased flood risks, declining groundwater levels, damaged ecosystems and difficulties for shipping and hydropower.

The DanubeSediment\_Q2 project is addressing these issues by improving sediment management across the entire Danube River Basin (DRB). It has developed the first-ever Integrated Sediment Management Plan and Sediment Improvement Strategy. Effective sediment management in the DRB depends on transnational cooperation. With 14 countries sharing the river's key waterways, solutions require coordinated efforts from both upstream and downstream regions.

# Cooperation for wildfires community resilience capacity building and early warning in the Black Sea Basin

Climate change – Wildfires – Community resilience

The Black Sea region is vulnerable to wildfires due to its diverse climate, topography and vegetation. Climate change is a key driver of wildfire intensification.

Capitalizing on the previous achievements of the project Co-Prevent, financed under the ENI CBC Black Sea Basin Programme, the Co-Resilience project aims to enhance community resilience, improve coordination and mitigate wildfire impacts.

Project partners aim to protect communities and ecosystems, promote sustainable management practices and reduce vulnerability to wildfires.

## Digital resilience to withstand the perfect storm

Flood infrastructure - Digital resilience -  
Climate change

STORM\_SAFE strengthens the digital backbone of critical flood and storm infrastructure.

Water control systems - such as storm surge barriers, locks and sluices - rely very much on digital technologies.

Outdated and unstable software can create serious safety risks. Failures in digital infrastructure could even lead to catastrophic consequences.

That is why STORM\_SAFE supports operators to build digital resilience. Pilots in five countries can be scaled up, helping communities across Europe to withstand extreme weather events.

## Blue Circular Nets

### Circular economy - Marine plastics - Fisheries

When fishing nets are approaching their end-of-life (EOL), the nets should be collected and disposed of appropriately.

Setting up a collection network in the demanding NPA circumstances requires extra efforts from all of those involved. On the other hand, this offers an opportunity to recycle and eventually reuse the collected materials.

The main outcome of the project is a Blueprint for collection, treatment and reuse of EOL fishing gear for the NPA region. In delivering this, CIRCNETS also prepares stakeholders involved in the fishing business for implementing legislative changes.

## Blue Growth Smart Adriatic Ionian S3

### S3 - Blue Growth - Economic development

The Adriatic-Ionian maritime area lacked a shared approach to blue growth. The BLUEAIR project addressed this gap. It developed the first transnational Smart Specialization Strategy (S3) for Blue Growth. Through workshops and matchmaking events, BLUEAIR has fostered synergies among policymakers, researchers and industry experts, creating a collaborative community dedicated to driving innovation in the sector.

The project identified best practices and investment opportunities, creating tools to support a more integrated approach to Blue Growth and improve governance models for national and regional administration.

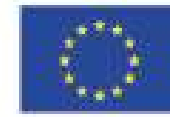

Smart Carbon Farming

## Smart Carbon Farming

**Reduction of greenhouse gas emissions  
sustainable agriculture - smart technologies**

Smart Carbon Farming aims at reducing agricultural greenhouse gas emissions, revitalising farmland and countering soil erosion by enhancing the carbon sequestration capacity of soils.

The project supports farmers in customising carbon monitoring and management systems for diverse regional conditions, such as varying soils, farm sizes and technological capacities. By working with 15 pilot farms in five NWE countries (BE, DE, FR, IE, NL), it shows how data-driven carbon farming improves sustainability.

In addition, 50 farmers will be trained and equipped to adopt these practices, unlocking new revenue streams. This approach not only advances the technological and business readiness of carbon farming innovations for a more sustainable agriculture in North-West Europe. It also fuels the transition to a more sustainable and resilient agriculture in the long run.

# 1. BUILDING SOLIDARITY

## Interreg transnational cooperation increases trust beyond borders for a stronger Europe

We actively accomplish the vision of a united Europe by bringing together people and organisations in our transnational projects. Our cooperation benefits everyone – both developed and less-developed regions - and makes sure that no region is left behind. There is a need for transnational programmes to remain able to address the current and long-term needs of different territories within their areas. This calls for the ability to tailor their strategies to the unique and specific challenges of their respective regions.



To achieve this goal, it is recommended that the new regulations incorporate the necessary flexibility to enhance the impact and inclusivity of transnational cooperation, and enable programmes to respond effectively to the (evolving) needs of the territories. Building on this, it is also recommended that the new regulations maintain the possibility to include and test emerging cooperation topics and allow the building of institutional capacity for dealing with them.

To conclude, it is also important that a future programme works to make it easier for SMEs and smaller organisations to participate in transnational Interreg projects.

Their contributions are valuable, and the more diverse actors there are in a project partnership, the stronger the potential outcome of the project.



## 2. ACHIEVING SYNERGIES

### **Interreg transnational cooperation makes the most of our resources, capacities and skills for a resilient Europe**

We address shared challenges with a long-term perspective. We work together beyond borders to find the most fitting solutions to regional challenges and arising opportunities. We help cities and regions to test and roll out new solutions, and to adapt and benefit from existing ones.



In post 27, the role of Interreg transnational programmes should be further acknowledged and strengthened as a unique platform that brings together expertise and know-how from different countries and sectors to work effectively on multifaceted common challenges of the involved territories.

The efficient use of Interreg and other EU funds could be enhanced through better synergies across different funding programmes and a more systematic capitalisation of project results at local, regional, national and EU levels.

To achieve this, it is necessary to harmonise programme rules, ensuring mutual coordination mechanisms across Interreg programmes and other EU initiatives. More resources and strengthened capacity for authorities managing the programmes at all levels are also needed.

**Transnational cooperation is essential for the long-term viability of joint responses to major societal EU challenges.**

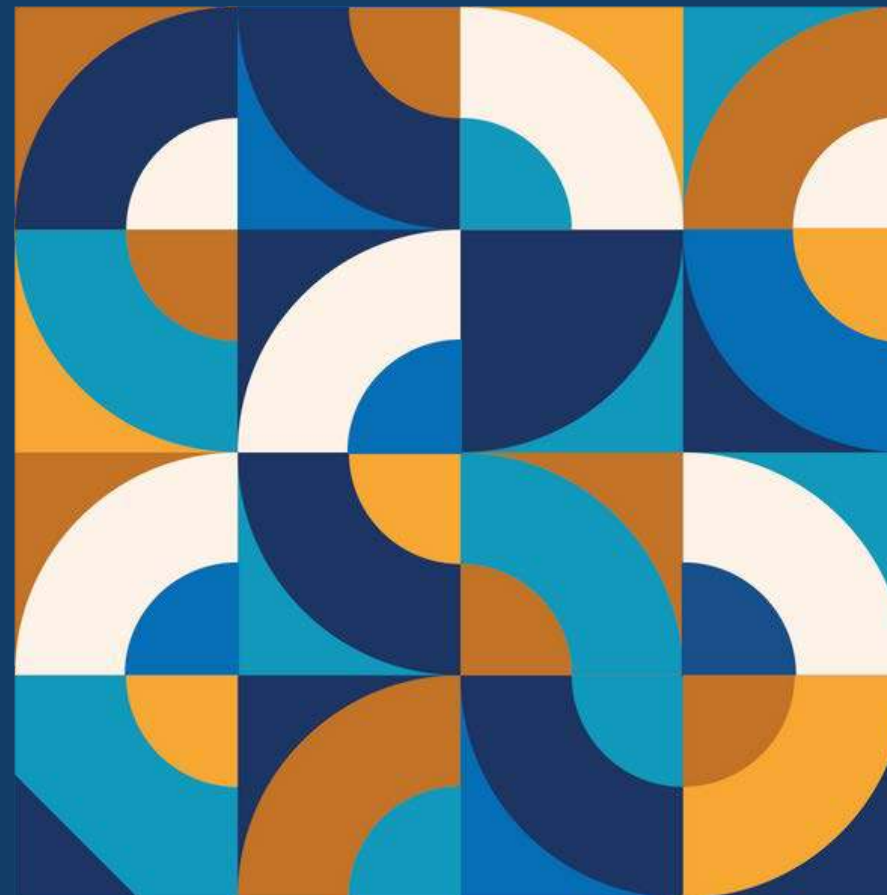
